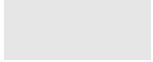

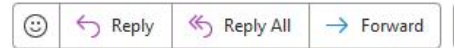

We are requiring live entry. The entry needs to be entered as Type 03 with all duties, taxes, and fees paid. Once payment is made, we sample and send it to the CBP Lab, and release the shipment. Once we get the results back from the lab, if it is not quartz, we liquidate and refund the overpayment of duties, taxes, fees. This entry needs to be retransmitted to Type 03 with AD/CVD case numbers at HTS changed to 6810.99.0020 (Unit of Measure M2).

Additionally, some of the sinks in this shipment were drawn sinks subject to AD/CVD. A new line item for those should be added and applied.


